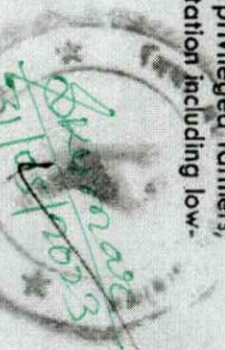

- 2.47 To undertake, organize, investigate, participate, sponsor, the human right programmes including awakening of human rights, preservation of fundamental rights, protection & safeguards to the victims of human rights violations, for the freedom, dignity and peace of the people. Also, undertake study, research, publications, treaties with national and international institutions and award programmes, for the effective implementation of Human Rights.
- 3. All the activities shall be Non Profitable and shall be done on 'No Profit-No Loss' basis.
- 4. All the incomes, earnings, movable/immovable properties of the trust shall be solely utilized and applied towards the promotion of its Aims and Objects only as set forth in the deed of its Aims and objects only as set forth in the deed of the trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past members. 8. Subject to the Provisions of Income Tax Act. 1961 as amended from time, the Trustees will keep the Trust Fund or such portion thereof, as they may, in their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other party for any loss invested in such shares, stock, securities and debentures of acquisition or mortgage by way of fresh charge on any immovable property in India, of free-hold or lease-hold tenure, and may deposit the amounts with any scheduled Bank, company or private firm or individual on such terms and conditions as they think fit, in the matter of investment of Trust funds, the provisions of section 20 of the Indian Trust Act shall apply; in the event of Trustees purchasing any immovable property or properties or advancing moneys or mortgage, they shall be entitled to accept such title or evidence of title as they shall think fit in their absolute and uncontrolled discretion. The Trustees shall have power, if any deed it in their absolute discretion to sell the Trust Fund or any part thereof and any such immovable property purchased by them under the power aforesaid and any other shares, securities, etc. and stand possessed of the money to arise from such sale upon after paying there out the expenses pertaining to such sale upon there out the expenses pertaining to such sale upon the Trusts and with the subject to powers and under these presents declared and contained concerning the Trust Fund which or the proceeds thereof, shall have laid out in purchase of property or properties as have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of taking effect.

9. **ADVISORY BOARD**

The recommendations made by Advisory Board in any matter are only suggestive.

10. **POWERS AND FUNCTIONS OF THE BOARD OF TRUSTEES:**

For the furtherance of the objects of the trust, the trustees shall have the following powers:  
To accept any donation, contribution grant loan or subscription in cash or kind, from any person (s) body of persons or Trust, Govt./ semi-Govt. department or agency, financial institution, bank, national or International donor with or without conditions.

- 10.14 To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustee to make such borrowing on payment of such interest and otherwise on such term and conditions as they may in their absolute discretion think fit.
- 10.15 To apply to the Government, public bodies, urban, local municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance including lease and substance of property with a view to promote the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters within the objects of the Trust and to put to any proper condition upon which such grants and other payments including taking land on lease may be made.
- 10.16 To take over or amalgamate with any other Charitable Public Trust, Trust, association, or institution with similar objects.
- 10.17 To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- 10.18 To take land/property on lease and then after sublease the land/property to the farmers and other organizations like co-operative/society/urban public bodies/gram panchayat or any being thereof in rural area/local municipal/district and other bodies corporation/company for farming/agriculture/ plantation purposes.
- 10.19 To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
- 11. The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.
- 12. The Trustees will not be entitled to receive any remuneration, but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

- 14.2 If he/she is requested to resign by 2/3rd or as near thereto as possible of the remaining trustees.
- 14.3 In the absence of Settler-Cum-Chairman, Secretary & Treasurer will take charge and function of Settler-Cum-Chairman.
15. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.  
The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:
  - 15.1 Five Trustees shall form a quorum for a meeting of the Trustees.
  - 15.2 All matters will be decided mutually by the Trustee.

The Trustees shall have the power to determine in case of doubt whether any money of property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
  17. MAINTENANCE OF BOOKS OF ACCOUNTS:-  
Regular books of accounts of the Trust shall be maintained incorporating all the revenue and expenditure and such books shall be closed once every 31st March.
  18. The Trust and the Trust funds shall be irrevocable for all the times.
  19. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose, which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.

The accounts of the Trust shall be audited every year by a Chartered Accountant or a firm of Chartered Accountants, that will be appointed by the Board of Trustees with the consultation of the Settler-Cum-Chairman.

**22. POWER & FUNCTION OF THE OFFICE BEARER  
SETTLER-CUM-CHAIRMAN:**

22.1.1 The Settler-Cum-Chairman shall preside at all meetings of the trust, when he/she is present and shall exercise such other powers as are conferred upon her by these rules. The Settler-Cum-Chairman may call for an emergency meeting through Settler-Cum-Chairman Signed notice in a shorter period. The decision of Settler-Cum-Chairman that a resolution has been carried or cast shall be conclusive, unless such a decision is challenged and a poll is demanded, on poll being demanded, the same shall be taken in such manner, as the Settler-Cum-Chairman shall have a second or casting vote.

22.1.2 The Settler-Cum-Chairman shall be the principal executive officer of the Trust and shall preside over the meeting of the Trust.

22.1.3 The duty of the Settler-Cum-Chairman shall be to ensure that the rules of the Trust and resolution of all the meeting are carried out and followed.

22.1.4 The Settler-Cum-Chairman shall call meeting of the Trust through the Managing Trustee as per rules and regulation.

22.1.5 The Settler-Cum-Chairman shall be the main executive officer of the Trust and shall conduct all official correspondences under his/her signature and he/she shall have supervision/administrative & financial powers over all the institutions of the Trust and shall have power of visiting and controlling the institutions as and when necessary for discharging his/her duties.

22.1.6 Settler-Cum-Chairman shall prepare all the agendas of meetings himself/herself if and/or with the consultation of the Managing Trustee or Trustee if required or desirable.

22.1.7 Settler-Cum-Chairman shall convey all meetings of the Trust as per scheduled and give intimations there of to the members in time.

22.1.8 All contracts shall be entered into his name on behalf of the Trust.

22.1.9 The Settler-Cum-Chairman should get the accounts audited according to the rules. Settler-Cum-Chairman NVer Change.

The bank accounts will be opened by the name of the Trust for its registered/administrative/branches, Project offices, centers or institutions run or conducted by the Trust with a Nationalized or scheduled bank or other bank appoint or permitted by Reserve Bank of India or in Post Office and shall be operated by joint signature.

24.1 The joint signatures of any two of the Shelter-cum-Chairman, Secretary and Treasurer will operate the bank accounts.

**24.2 AMENDMENTS**

This Trust, Trust-fund, trust objective and the provisions relating to the appointment of the Settler constituting the Board are irrevocable. Subject as aforesaid, the terms of this deed may be amended, altered or modified by a majority of 2/3rd members of the Board present and voting in a meeting called for the purpose.

Provided, however, that no amendment contrary to the objects of the Trust herein before set forth shall be valid and effective

**24.3 DISSOLUTION OF TRUST:**

In case of the dissolution of the Trust the remaining assets after satisfaction of all its debts and liabilities shall be handed over to any public charitable Trust or Society having, similar or partially similar objectives, which has been registered under section 12A of the Income Tax Act. or by the direction of settler (which expression shall deemed to include his/her survivors, heirs, Executors, successors, legal representatives and assignees) and shall provide a competent managements and bodies for its sponsored institutions to promote aims and objects of the "Trust Dissolved". In case of any dispute the Trust will be dissolved after taking permission of competent courts.

**JURISDICTION OF COURT:**

The competent court in Bhojpur (Bihar) shall have exclusive jurisdiction to decide any question regarding the interpretation and construction of



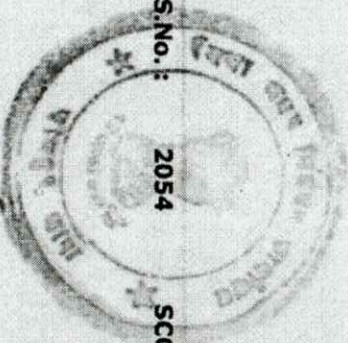
